Individual liberties vs National Security: is that the choice we have before us as the US Congress debates the renewal of some provisions of the Patriot Act. Our own Senator strong supports strengthening some provisions of the Act. Equally conservative Republicans and most Democrats favor revising or eliminating approximately 12 provisions of the Patriot Act.

So, do we have to choose between individual liberties and national security? As is so often true, the answer is not yes or no. It is, I think, some of and none of both. How do you like that double speak? Let me be clear. The law is aimed at International Terrorists. However, it has been expanded under the Foreign Intelligence Surveillance Act, 1987(FISA) to include access to business, library, and medical records (Section 215) when those records are said, by the FBI, to be relevant to investigation of terrorist activities. How then, are we to make some reasonable decision on what we want the Act to do? I will need less gratuitous secrecy for starters. Secondly, I will need competent investigative agencies. Reports on the efficacy the CIA and FBI have been hugely underwhelming. Further, I'd like a real and unchanging definition of what or who a terrorist is. Some of us have had dogs, cats and children who were considered terrorists. Hopefully not what or whom Attorney General Gonzales has in mind.

I don't believe the sacrifice is about giving up even ONE civil liberty. I do believe that it is about making a personal commitment to pay attention to all of the news and then acting on the information. Each of us knows how to do this. It is a matter of giving up lazy, uninvolved ways and picking up the flag of "things must change and I must be willing to ask the hard questions and/or take what maybe uncomfortable actions." Status quo is comfy but often neither rewarding nor satisfactory. I think it was B. Franklin who said, "the price of liberty is eternal vigilance."

In June 2005, LWVUS Council will convene. Because the Patriot Act was number one or two at our 2004 Convention, I anticipate that we will have study information from Council. I look forward to receiving solid and coherent information from League. Take every care. I have been honored and rewarded beyond my imagination at being your president for the past four years. No, I won't be like an old soldier. I will remain actively involved in League. In case you haven't noticed, it's addictive. I hope each of you will be a delegate to the LWV Utah convention, April 29 and 30. Please call me if you would like to attend, 583-6932.

Editors note: In a press release dated April 5, the League of Women Voters of the United States (LWVUS) announced its support of the Security and Freedom Enhancement (SAFE) Act of 2005, and commended Senators Larry E. Craig and Richard J. Durbin for their leadership in introducing this important legislation. "The League believes that the SAFE Act will address the concerns of the American people about the excesses of the USA Patriot Act. By placing limits on "sneak and peek" searches and "John Doe" roving wiretaps and requiring increased public recording on the use of the Foreign Intelligence Surveillance Act, the SAFE Act will protect innocent Americans from unrestricted government surveillance."

Preview Forum uses clips from recent and forthcoming films and television programs to focus on how advances in technology, ownership and government regulations have altered the new media landscape. How do we, as citizens, respond in this media environment?

The forum features previews of upcoming television and radio programs, new features and other national media projects to bring together news professionals and the public in local forums to discuss social issues relevant to the community. The goal is to use nationally broadcast media to promote dialogue and provide the opportunity to address issues that often become narrowly defined debates. Participating nation organizations include the American Library Association, Associated Press Managing Editors, League of Women Voters of the United States, National Civic League, On the Media, WNYC, Radio and Television News Directors Association.

The Forum will provide resources to organizations across the country to host Preview Forums. Free educational materials are provided that can be tailored to the needs of local community partners as well as national organizations. Videos, planning and topic guides, facilitator's training kits, flyers and postcards, press release and publicity templates, an online learning center and a website are available for organizations at no charge. (Continued from page 1) Salt Lake City Public Utilities Department, will talk about the history, development, and health of the city's watersheds. His powerpoint presentation will include an historical view of developing water for Salt Lake City residents, identifying and purchasing lands in our watershed (an ongoing process), monitoring the water quality of creeks and streams, and dealing with issues created by the increasing public use of the watershed areas. Mr. Ward assured me there will be time for a Q & A period also. We expect this to be approximately a two-hour program.

So eat an early dinner, car-pool to the nearest TRAX station--or transport yourself to the Salt Lake City government building's east entrance, the door that faces the new library. Room 326 is on the north end of the third floor (turn right out of the elevator; room numbers are not logical, I'm told). This will be an informative evening, which provides us an opportunity to learn and ask questions about a range of watershed issues that deeply interest many of us.

"It is worth considering the strange media landscape in which political talk radio is a salient. Never before have there been so many national news sources-different now in terms of both medium and ideology...All this is well known; it's part of the Media Environment we live in. But there are prices and ironies here. One is that the increasing control of U.S. mass media by a mere handful of corporations has-rather counterintuitively-created a situation of extreme fragmentation, a kaleidoscope of information options. Another is that the ever increasing number of ideological news outlets creates precisely the kind of relativism that cultural conservatives decry, a kind of epistemic free-for-all in which 'the truth' is wholly a matter of perspective and agenda. In some respects all this variety is probably good.... But it can also be confusing and stressful for the average citizen...it is increasingly hard to determine which sources to pay attention to and how exactly to distinguish real information from spin.

...Whatever the social effects of talk radio or the partisan agendas of certain hosts, it is a fallacy that political talk radio is motivated by ideology. It is not. Political talk radio is a business, and it is motivated by revenue."
