	This article is from a League member and reflects her opinions.
VOTER FRAUD	Voter fraud is defined as ineligible people voting, not simply as ineligible per- sons being listed on the voter registration rolls. Due to the lack of any requirement to remove yourself from voting rolls when you move or die, etc. virtually all voting rolls have lots of extra people on them. However, the academic research shows over- whelmingly that there is virtually no voter fraud occurring in the U.S. with the excep- tion of the Washington DC area where approximately 300 voters, reported in one study, were found to have crossed into Maryland to be able to vote in the Presidential
&	election.
VOTER ID	Unlike vote fraud which is undetectable, voter fraud is simple enough to detect by looking at the poll books and official register of voters. In fact, an exhaustive search for illegal voters in the 8 month-long contest by both Democrats and Republi- cans in the 2004 Washington State Gubernatorial race found only 7 illegal voters in the entire state and all were ex-felons who had neglected to go through the process to re-establish their right to vote after serving their time. That is a pretty typical rate and

This article is from a League member and reflects her opinions and life experiences.

My family has been involved in the ranching industry for over thirty years. What started as a small 100 acre ranch in the Uintahs has expanded to a feedlot and farm in Corinne and a large ranch in Ruby Valley, Nevada. In the early 1980's we hired an illegal immigrant, Francisco Nava to help us with our pursuits. From time to time, since then, we have hired other illegal immigrants to help with building fences, brandings, and such other work that comes with the territory of ranching. All these men have been hard working, good individuals. We have always enjoyed their company.

After Francisco had been with us awhile the amnesty program was made available. We, thus, were able to get a "green card" for him. When that was accomplished, Francisco and I set about getting visas for the rest of his family. We spent endless hours waiting in lines at the U.S. Immigration office obtaining forms and filling them out. We had to send for birth and marriage certificates from his family in Quechultenango. After finally filing the papers, it was another three years before we heard we could proceed. Francisco had to fly to Mexico City and meet his family to help them pass physicals and fill out more paper work. At last, all did receive their visas. One by one his family began to come to the states. Two sons, Miguel and Jose, have graduated from Cottonwood High School. Another is to graduate this spring. The Navas now own a home in Midvale and are a family all together again.

Francisco first crossed the border by riding the undercarriage of a train's freight car. Another lady's progenitors crossed the hot desserts of Mexico in order to work in the fields of the Santa Clara Valley in California. This lady is Anna Escobedo Cabral, United States Treasurer. Anna is the oldest of 5 children. Her father worked very hard at many jobs to buy the family a home. The home was lost when he became disabled. The family then rented a shanty down by the tracks.

At 16 years of age, Anna decided to graduate from high school early in order to go to work and help support her family. She was a very good student. Her math teacher, Mr. Phillip Lamm, told her she should go to college. Mr. Lamm helped her fill out the application and apply for scholarships. Anna did receive a scholarship to the University of California, Davis. This scholarship not only covered her expenses, but she also found some extra funds to send home to her family.

Graduating from UC Davis, she went on to the John F. Kennedy School of Government Administration for a Master's degree. Later, both she and her husband, Victor, went on to achieve further degrees at Harvard. Anna's was in law. During this whole process, Victor and Anna have raised four very successful children, Raquel, Viana, Catalina and Christopher.

Prior to her position as United States Treasurer, Anna has been the Director of the Smithsonian Institution's Center for Latino Initiatives and President and CEO of the Hispanic Association on Corporate Responsibility, a national non-profit organization which partners with Fortune 500 companies to increase Hispanic representation in corporate America.

Anna's signature is found in the left hand, lower corner of many dollar bills. Perhaps one of the best ways she likes to make her presence known, though, is through visiting grade school kids. She states, "I am amazed about the kind of joy that elementary school kids have about education. They are so full of energy and enthusiasm. Something happens to these kids. They are lost by the time they get to high school. This is one reason that President Bush's No child Left Behind Act for education is very important."

Francisco and Anna represent all that is good of those who have recently migrated to the United States. There must be some good kind of legislation which will bring abundant work permits, visas, and eventual citizenship. These people continually revitalize our country.
