League planning for the future will highlight our May League meetings. Gigi Brandt will meet with us on Monday, May 11, at 5:30 at Girl Scout Headquarters for a general meeting (no units this month) to brainstorm Salt Lake League study and action. Please check out her article and our current program in this *Salt Lake Voter.* Since September we have concentrated on improving transportation, renewable energy use, air quality, health care, voter service and observing government in action. What would *you* like to see the League take on next?

We're also looking forward to the biennial League of Women Voters of Utah Convention, to be held May 15-16 at the Red Lion in downtown Salt Lake City. The convention begins at 4 p.m. on Friday May 15. We will hear the presidents' report and get a preview of program and budget proposals before dinner at 6:30. Voting Equipment Security will be addressed by experts Paul Lehto, an election attorney and author; and Jim Marsh, a founding member of Black Box Voting. Nikki Norton and Glen Wright will explain the Fair Boundaries group's initiative petition for an Independent Redistricting Commission, and Ann O'Connell will report on the national League-sponsored *Conference on Issues and Solutions for Adapting to Climate Change* that she just attended in Washington. Buffet breakfast and lunch will be provided.

Our 12:30 luncheon speaker will be David Irvine, a leader in putting an initiative on the Utah ballot that would establish an independent ethics commission. Mr. Irvine has worked for years to end torture by the American government; he takes on the tough issues. Before adjourning at 3 we'll address the future business of the League, elect new officers, approve League program and budget, and give direction to the new board.

# News from National League

**National Council**. Speaking of planning, the League of Women Voters of the United States uses annual conventions and councils for future planning, too. This year, the economy has led them to plan a National Virtual Council meeting. Instead of traveling to Washington D.C., state and local league presidents can participate in a webinar type broadcast on June 13 from 11 a.m. -2 p.m. MT. National encourages having a viewing party with the ability to project onto a larger screen, although voting by delegates will depend on individual computer log-ins. Utah League Co-President Alice Steiner is planning such a viewing party with lunch brought in, place to be determined. One issue is that the audio portion will be via phone, so the viewing party will need a speaker phone with good projection capabilities.

**National Voter.** Also due to the economy, the *National Voter* has been temporarily suspended. In the meantime, do check <u>www.lwv.org</u> for bountiful information on League national priorities: Global Climate Change, Health Care, Election Reform and D.C.Voting Rights – which just happen to be our priorities.

**National Health Care**. While health care reform is under way in Utah, it's likely in the view of experts such as Judi Hillman that comprehensive reform will happen at the national level first. Most recently, LWVUS President Mary Wilson told our representatives in Congress that "...the League believes that quality, affordable health care should be available to all U.S. residents. Other U.S. health care policy goals should include the equitable distribution of services, efficient and economical delivery of care, advancement of medical research and technology, and a reasonable total national expenditure level for health care. Furthermore, the League believes that all Americans should have access to a basic level of care that includes the prevention of disease, health promotion and education, primary care (including prenatal and reproductive health), acute care, long-term care and mental health care. "Through decades of work in their communities, League members have learned that Americans believe that fairness and responsibility, as well as access, are important values for any health care system. We believe that healthcare reform can only succeed if it takes all these values into account."

## Report from Washington on Global Warming Ready or Not?

I have just returned from a conference in Washington, D.C. entitled Ready or Not? A Conference on Issues and Solutions for Adapting to Climate Change. The League of Women Voters of the US, OXFAM, and the National Wildlife Federation are among the long list of sponsors, which also includes many church groups and nonprofits directly concerned with the effects of global warming on the poor both in this country and around the world. The LWV of Salt Lake was asked to send a delegate rather at the last minute because our Congressman Jim Matheson is on the Energy and Environment Subcommittee of the House Energy and Commerce Committee. The subcommittee and then the full committee are in the process of developing the American Clean Energy and Security Act, sometimes called Markey-Waxman bill after the senate and house sponsors.

From the newspaper, emails, blogs, etc. you have no doubt heard that there is concern about how Representative Matheson might vote on this bill and/or how he might work to change it from its original form. And this is the week for "mark-up" of the bill in the subcommittee. If that term sounds a bit like editing a report, that is not too far from the truth; however, keep in mind that a major part of editing can be cutting things out or making major changes to content.

The LWVUS and other sponsors of the *Ready or Not Conference* support the original bill and intended that the conference would facilitate lobbying critical committee members. To this end, I and Christina Vamvas, the LWVUS grassroots lobbyist visited Matheson's office. Here I should point out that the representative is concerned about global warming and wants to see a bill passed. He, however, wants to spend more time working on specifics of the bill that he feels uneasy about. The LWVUS and others are equally concerned that a bill that comes through the process with too many changes will not be the climate change legislation we want. This, of course, makes for a difficult conversation, but then that is what the legislative process (and politics) is all about.

If you want more specifics about the bill go to <u>www.lwv.org</u> – click on Join Us in Urging Action Against Climate Change. There is a lot of information there. You will notice that the LWVUS is placing emphasis on International Adaption to Climate Change and therefore is asking Congress to include funding for aid to the communities in third world countries that are suffering most from the changes that are already upon them. This was a major theme of the Ready or Not Conference.

It seems that although the large countries of the world are the ones who are mainly responsible for global warming, it is the small communities which can best confront the climate changes that are occurring even now. Money should go to on-the-ground projects initiated and carried out by local communities. There may be some need for large programs and infrastructure projects but we should question if that is the best investment in the long run.


FYI – We will meet in a different room than usual. Folks should come in the front door and to the second floor – we'll post signs so that it's clear where to come.

## Speaking of Program. . . Are Initiative Petitions Part of the League's Future?

Many citizens were interested when Governor Jon Huntsman announced the formation of a Commission on Strengthening Utah's Democracy this winter with the charge to study ethics laws (gifts, conflict-of-interest laws and an independent ethics commission), campaign finance laws, redistricting laws and procedures, lobbying regulations (disclosure and revolving door issues) and elections (the caucus and convention nominating system, open or closed primary elections, voter registration laws, and voting system options). The day before the commission's April 16 meeting, the Governor withdrew his charge to study ethics and redistricting laws from the commission's list, at the request of House Speaker David Clark, who said

that under the Utah Constitution ethics and redistricting are the responsibility of the legislature.

Those members who attended the April unit meetings know that the League of Women Voters of Utah has been included in groups considering two initiative petition drives to put a non-partisan redistricting commission and a non-partisan ethics commission for state offices on the ballot in 2010. Both groups think that this may be the only way to get these laws or some reform enacted into Utah law.

At press time neither group has formalized its petition. The redistricting initiative group Fair Boundaries (at www.fairboundaries.org) will present a workshop on their drive at the League's State Convention on May 16. David Irvine, who is drafting the ethics commission initiative, will speak to the convention at lunch on May 16.

Using initiative petitions to enact law is a rigorous process, made more difficult by the legislature a few years ago. To put the proposed law on the ballot requires 90,000 signatures (10 percent of the total votes cast for governor in 2008). This includes 10 percent of the votes cast for governor within each of 26 (out of the 29) Utah Senate districts. Most of us remember the work required to put vouchers on the ballot in 2007, and many worked on an earlier failed initiative petition drive to ban guns from schools.

The next meeting of the governor's Commission on Strengthening Utah's Democracy will be in Salt Lake on Thursday, May 21, from 3-5:30 p.m. Place to be announced. See http://www.strengthendemocracy.org/meetings/

## **Not Forgotten**

Many of us have fond memories of Salt Lake League members we have recently lost.

**Peggy Shaw** was a native of Logan and a member of the League since the 1950s. In fact just two months ago she became eligible to be enrolled with the national League as a 50-year honorary member. She received a degree in Chemistry at Utah State University. She and her husband Roy traveled the world. They visited over two dozen countries and lived in Peru and the Phillipines. Peggy was proud to serve on both the Salt Lake City and Utah State boards of this organization and we especially benefited from her skills and judgment as treasurer. She continued to contribute to the League financially after retirement, and her work inspired her niece, attorney Joyce Maughan, to join us as well.

**Dottie Bintz** was born in New Jersey then spent part of her childhood in China, where her father was a diplomat for the United States, before returning to Trenton. She attended Cornell University and met her future husband Tom Bintz. He was from Salt Lake City, where they subsequently made their home. She was an accomplished diving and tennis champion, co-authored "Baby Love," an educational comic book about infant care, sang with the Junior League Choraleers, Utah Symphony Chorus, Jay Welch Chorale, and Oratorio Society, and participated in many other civic and community groups. # Wasatch Canyons Tomorrow

The Wasatch Canyons Tomorrow\_process is a once-in-a-generation opportunity to create a broadly supported public vision for the future of Salt Lake County's major Wasatch Canyons: City Creek, Emigration, Red Butte, Parley's, Millcreek, Big Cottonwood, and Little Cottonwood. The vision will form the basis of an overdue revision of the Salt Lake County Wasatch Canyons Master Plan (adopted in 1989) and include principles, best practices and tools to guide future management policies. The Wasatch Canyons Tomorrow process seeks to explore management alternatives and to educate the public on growth impacts on the canyons and watersheds. Likely issues include watershed protection and water quality, transportation, recreation and public access, natural resource management, land-use regulations, and public safety and hazards.

The State of Utah, Salt Lake County, Salt Lake City, and the U.S. Forest Service are jointly sponsoring this process, and Envision Utah is facilitating it. The public will be able to voice their preferences for the canyons' futures through workshops, open houses, and on-line surveys.

With the doubling of county's population in the next 30 years, *Wasatch Canyons Tomorrow* will strive to ensure the long-term health of these treasured canyons, balancing land-use, transportation, and environmental concerns.

## Kick-Off Event (May 7<sup>th</sup>)

On May 7<sup>th</sup>, a kick-off event will take place at City Creek at 11:00 a.m. Governor Jon Huntsman, Mayor Peter Corroon, Mayor Ralph Becker, and Brian Ferebee, Forest Supervisor, will explain their support of this process and the importance of the Wasatch Canyons to our region.

## Workshops (May 12<sup>th</sup>, 13<sup>th</sup> and 14<sup>th</sup>)

Educational workshops will inform the public about canyon issues and stimulate informed participation in the process. Interactive keypad polling gauges reaction to planning strategies in real time; participants will anonymously vote on survey questions. Workshops will begin at 6:30 p.m.
