2020 Watermaster Report for District 29D

Very little water usage was measured by District 29D watermaster Harold (Hal) Armstrong during 2020 due to measuring devices not being in place. During the season, measuring devices were in process of installation many of which have been or will be installed by water irrigation season 2021.

Measuring devices will be required to be in place at the beginning of irrigation season 2021 at which time measurement of water usage will begin and be reported.

Since approximately 15 24 hour days were estimated for the total water usage. The daily use times 15 was estimated usage for the season since no one uses the water every day but at least once a week. The total CFS decreed for District 29D is 289.04 CFS per 24 hour day. The total usage and delivered rate per day was 66.41 CFS. Total CFS decreed for 15 days is 4,335.60 CFS. The estimated actual water used for irrigation season 2020 was 996.19 CFS which is 23% of the total decreed water CFS.

See the following pages for a summary compilation of the estimated usage and delivered water for 2020 in detail by water rights at the diversion (Spatial ID) points. The remaining water was not used and delivered due to non-usage, non-consumptive, or various other reasons.
