Note your session number. You may return to it and edit it for up to 180 days, making a continuing garnishment easier.

**** Note** that the judgment creditor may have submitted **additional interrogatories** herein that do not appear in the online form. It is your obligation to review these additional interrogatories and provide all relevant information the judgment creditor may desire in accordance with rule 64D(e)(7) of the Utah Rules of Civil Procedure.

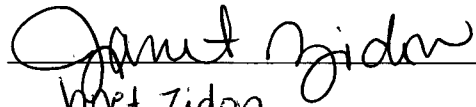
