It is your obligation to review these additional interrogatories and provide all relevant information the judgment creditor may desire in accordance with rule 64D(e)(7) of the Utah Rules of Civil Procedure.

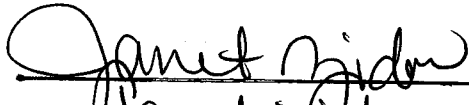
