Carriage subject to tariffs, rules, and regulations in effect on the date of shipment and to conditions of contract.

CONDITIONS OF CONTRACT

1. Carriage and other services performed hereunder are subject to these conditions and to the rates, rules and classifications set forth in the Carrier's currently effective tariffs, which are available for inspection and incorporated into this contract by reference.
 2. As used in this contract, "Carrier" means Technical Transportation, Inc. and its authorized agents.
 3. In tendering the shipment for carriage, the shipper warrants that the shipment is packaged to protect the enclosed goods and to insure safe transportation with ordinary care in handling, and that each package is appropriately labeled and is in good order for carriage as specified.
 4. All shipments may, at Carrier's option, be opened and inspected.
 5. Carrier shall not be liable for loss, damage, delay or other results caused by (a) acts of God, public enemies, public authorities acting with actual or apparent authority, authority of law, quarantine, riots, strikes, civil commotions, or hazards or dangers incident to a state of war; (b) the act or default of the shipper or consignee, including any breach of warranty set forth in Paragraph 3 above; (c) the nature of the shipment, or any defect, characteristic or inherent vice thereof; (d) violation by the shipper or consignee of any of these conditions of contract; (e) compliance or non-compliance with delivery or special instructions.
 6. Carrier shall not be liable for special or consequential damages.
 7. In consideration of Carrier's rate for the transportation of any shipment, which rate, in part, is dependent upon the value of the shipment, the shipper and all other parties having an interest in the shipment agree that the limit of Carrier's liability shall be the lesser of:
 - (a) the amount of any damages actually sustained; or
 - (b) which of the following is greater:
 - (1) the shipper's declared value stated on the face hereof; or
 - (2) \$.50 per pound multiplied by the weight of the damaged material;
 - (3) \$50 per shipment
- plus the amount of the Carrier's transportation charges applicable to that part of the shipment lost, damaged or delayed. Unless a different amount is specified by the shipper, the declared value on a C.O.D. shipment shall be deemed to be the C.O.D. amount. Declared Value on used or pre-owned equipment is limited to loss or theft only as the cosmetic and mechanical condition of the material is unknown to Technical Transportation, Inc.
8. The shipper and the consignee shall be liable, jointly and severally, (a) for all unpaid charges payable on account of a shipment pursuant to this Contract, and (b) to pay or indemnify Carrier for all claims, fines, penalties, damages, costs or other sums which may be incurred by the Carrier by reason of any violation of this Contract or any other default of the shipper or consignee or their agents. Terms of payment for invoices are NET 30 days. Invoices not paid within terms are subject to a 10% interest charge.
 9. Carrier shall have an automatic lien on goods for the carrier's lawful charges for transporting and storing the goods. This includes storage charges incurred while waiting for the shipper or consignee to pay charges.
 10. In the event of failure or inability of the consignee to take delivery of the shipment, Carrier will notify shipper in writing at the address shown on the waybill and request disposition instructions. If the shipper fails to provide disposition instructions within 30 days after the date of Carrier's notice, Carrier will return the shipment to the shipper at the shipper's expense. If the shipper fails to accept delivery of a shipment thus returned Carrier may, upon 30 days written notice to the shipper, dispose of the shipment at public or private sale and pay itself out of the proceeds to satisfy the transportation charges owing on the shipment. Any sums collected by Carrier in excess of such transportation charges will be paid to the shipper. No sale or disposal pursuant to this rule will discharge any liability or lien to any greater extent than the proceeds thereof. The shipper and the consignee shall remain liable, jointly and severally, for any deficiency.
 11. Claims for loss or damage discovered by the consignee after delivery and after a clear receipt has been given to Carrier must be reported in writing to Carrier within 15 days after delivery of the shipment, and CARRIER shall be given the opportunity to inspect the shipment and its container(s) and packing material within 15 days after receipt of such notice.
 12. Claims for loss, damage or delay must be made in writing within a period of 180 days after the date of acceptance of the shipment by the carrier.
 13. No Claims with respect to a shipment, any part of which is received by the consignee, will be entertained until all transportation charges have been paid.
 14. Claims for overcharges or duplicate billings must be made in writing within a period of one year after the date of acceptance of shipment by the Carrier.
 15. Carrier shall not be liable in any action unless a claim has been filed and such action is brought within 1 year after the date written notice is given to the claimant that carrier has disallowed the claim in full or in part.
 16. To the extent that it is not governed by Federal Law, this Contract and the tariffs incorporated by reference shall be construed and the performance of the transportation hereunder shall be determined in accordance with the laws of the State in which the shipment is accepted by the Carrier. If any provision of this Contract, including the tariffs incorporated by reference is determined to be invalid or unenforceable, the remainder of the Contract, shall not be affected thereby.
