9 THIS IS A WRIT FOR A CONTINUING LIEN, THE GARNISHEE SHALL HOLD the  
10 non-exempt portion of the defendant's earnings due at the time of service  
11 of this writ and shall also hold the defendant's non-exempt earnings that  
12 accrue through the last payroll period ending on or before **SIXTY days**  
13 after the date of service of this writ. HOWEVER, IF THE GARNISHEE IS  
14 PRESENTLY HOLDING THE NON-EXEMPT PORTION OF THE DEFENDANT'S EARNINGS  
15 UNDER A PREVIOUSLY SERVED WRIT FOR A CONTINUING LIEN, THE GARNISHEE SHALL  
16 HOLD UNDER THIS WRIT only the defendant's non-exempt earnings that accrue  
17 from the date the previously served writ or writs terminate and through  
18 the last payroll period ending on or before sixty days after the date of  
19 termination of the previous writ or writs. IN EITHER CASE, THE GARNISHEE  
20 SHALL STOP WITHHOLDING WHEN THE SUM WITHHELD EQUALS THE AMOUNT STATED IN  
21 THIS WRIT OF GARNISHMENT.

22 YOU ARE HEREBY COMMANDED, unless otherwise directed by the Court, by  
23 the attorney for the plaintiff, or by this writ, not to pay any debt,  
24 whether earnings subject to this garnishment or any other debt, owed to  
25 the Judgment Debtor at the time this writ was served and not to deliver,  
26 sell, or transfer, or recognize any sale or transfer of, any personal  
27 property or effects of the Defendant in your possession or control at the  
time when this writ was served. Any such payment, delivery, sale, or  
transfer is void to the extent necessary to satisfy the Judgment  
Creditor's claim and costs for this writ with interest.

YOU ARE FURTHER COMMANDED to answer this writ according to the  
instructions in this writ and in the answer forms and, within **TWENTY days**  
after the service of the writ upon you, to mail or deliver the original  
of such answer to the court, one copy to the Judgment Creditor or the  
Judgment Creditor's attorney, and one copy to the Defendant, at the  
addresses listed at the bottom of this writ.

If, at the time this writ was served, you owed the Defendant any earnings  
(that is, wages, salary, commission, bonus or other compensation for  
personal services or any periodic payments pursuant to a  
nongovernmental pension or retirement program), the Defendant is

1 entitled to receive amounts that are exempt from garnishment under  
2 Federal and state law. You must pay the exempt amounts to the defendant  
3 on the day you would customarily pay the compensation or other periodic  
4 payment. As the greater of seventy-five percent of disposable earnings  
5 or a minimum amount determined by reference to the employee's pay period,  
6 to be calculated as provided in the answer. However, if this writ carries  
7 a statement in the heading that "This garnishment is based on a judgment  
8 or order for child support," the basic exempt amount is fifty percent of  
9 disposable earnings.

10 YOU MAY DEDUCT A PROCESSING FEE FROM THE REMAINDER OF THE EMPLOYEE'S  
11 EARNINGS AFTER WITHHOLDING UNDER THIS WRIT. THE PROCESSING FEE MAY NOT  
12 EXCEED TWENTY DOLLARS FOR THE FIRST ANSWER AND TEN DOLLARS AT THE TIME  
13 YOU SUBMIT THE SECOND ANSWER.

14 If you owe the defendant a debt payable in money in excess of the  
15 amount set forth in the first paragraph of this writ, hold only the  
16 amount set forth in the first paragraph and any processing fee if one is  
17 charged and release all additional funds or property to defendant.

18 IF YOU FAIL TO ANSWER THIS WRIT AS COMMANDED, A JUDGMENT MAY BE  
19 ENTERED AGAINST YOU FOR THE FULL AMOUNT OF THE PLAINTIFF'S CLAIM AGAINST  
20 THE DEFENDANT WITH ACCRUING INTEREST, ATTORNEY FEES, AND COSTS WHETHER OR  
21 NOT YOU OWE ANYTHING TO THE DEFENDANT. IF YOU PROPERLY ANSWER THIS WRIT,  
22 ANY JUDGMENT AGAINST YOU WILL NOT EXCEED THE AMOUNT OF ANY NON-EXEMPT  
23 DEBT OR THE VALUE OF ANY NON-EXEMPT PROPERTY OR EFFECTS IN YOUR  
24 POSSESSION OR CONTROL.

25 JUDGMENT MAY ALSO BE ENTERED AGAINST THE DEFENDANT FOR COSTS AND  
26 FEES INCURRED BY THE PLAINTIFF.

27 This writ is issued by the undersigned attorney of record for the  
28 plaintiff under the authority of Chapter 6.27 RCW, and must be completed  
29 with in the same manner as a writ issued by the clerk of the court.
